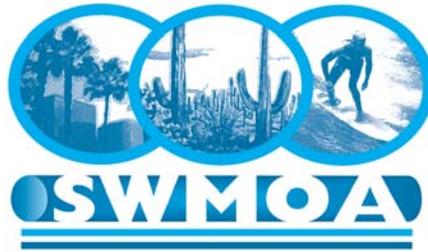

RECENT ACTIVITIES:

A mysterious phenomenon was reported in Pleasanton, California last month. Several membrane treatment operators found that hats no longer fit on their heads. As it turns out, recent attendance at the SWMOA Hands-on Training Workshop hosted by Zone 7 Water Agency caused several participants' heads to expand – a consequence of receiving too much knowledge in one sitting.

All joking aside, this Northern California event was a spectacular example of what SWMOA is here to do – bring operators together to share experiences and knowledge. Operators from all over California attended this workshop to learn about Zone 7's Mocho Groundwater Demineralization Plant (MGDP) and groundwater RO treatment in general. Zone 7 staff was instrumental in kicking off the event with an overview of the Zone 7 Water Agency and provided outstanding tours of MGDP in the afternoon. Carollo Engineers did a great job conveying their experience with MGDP startup and how Zone 7 was successful in obtaining approval for remote operation of the facility. Attendees learned about chemical pre-treatment from Avista Technologies, high pressure pumps from Afton Pumps, cartridge filtration from Parker Hannifin and Valin Corp., RO element construction from SPI, RO membrane installation from Hydranautics, and RO pressure vessels from Bekaert Progressive Composites. All in all, a very successful event!

Let your friends at other water districts know about SWMOA - we are dedicated to providing a forum for membrane system operators to exchange information, experience and knowledge. As important, we provide educational credits through our workshops and hands-on training necessary for Operator Certification.
